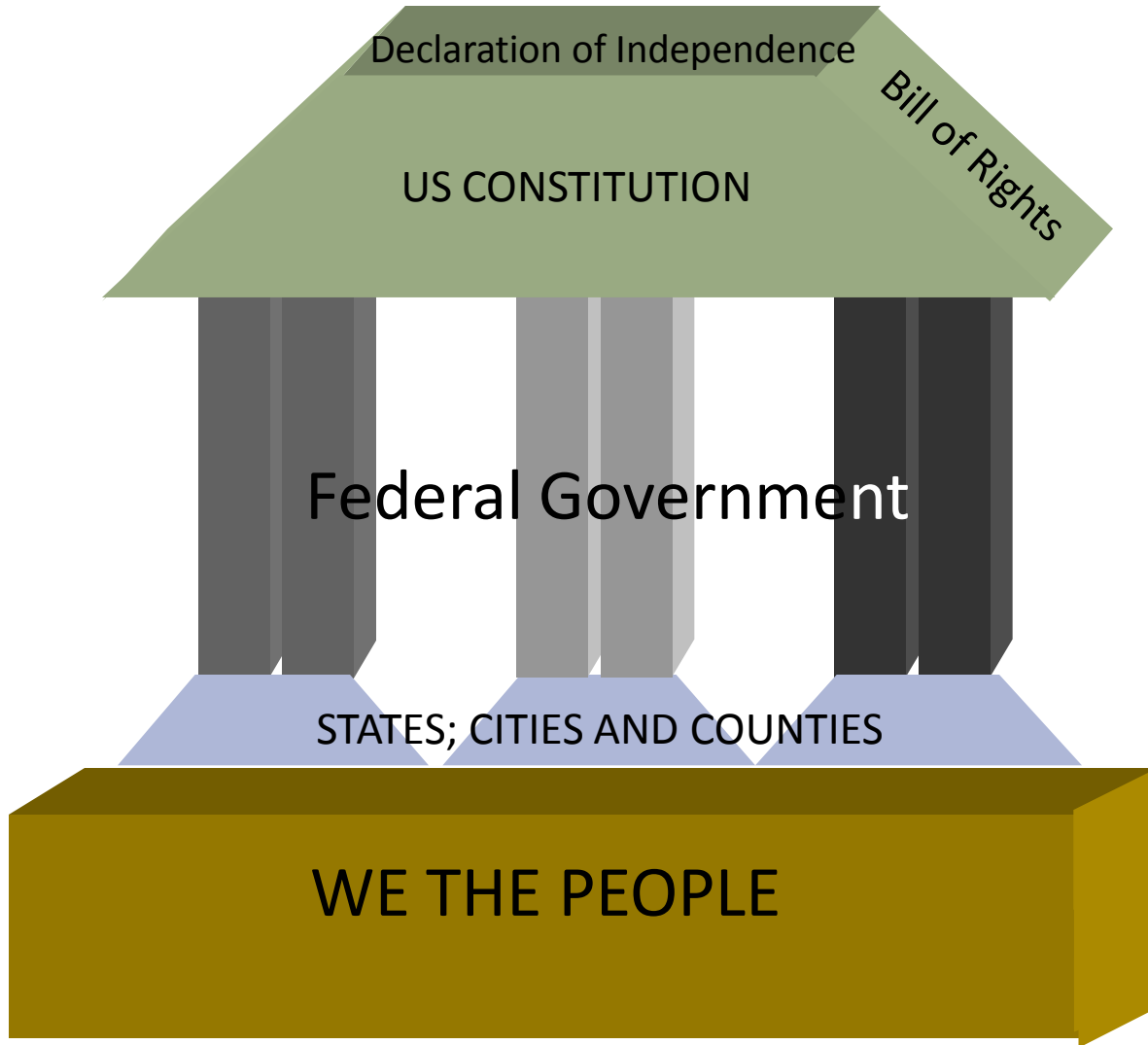


ENVIRONMENT
